

INTERNATIONAL MINISTRY APPLICATION FORM

Thank you for your interest in inviting From His Fullness Ministries to your country. We welcome invitations to minister internationally since we desire is to serve the church globally, particularly by biblical exposition, theological education, training in church leadership, and by ministry to women.

We are open to new friendships and global partnerships, but give priority to those church or ministry applicants which are:

- Classically Protestant, self-consciously evangelical, and confessionally Reformed (or wanting to learn more of the faith of the Reformed).
- Known first- or second-hand to us, or who can be verified by a compelling website or reliable references.
- Willing to agree upfront to a sharing of the costs of the ministry. We are mindful of local constraints and are not unreasonable in discussing these, but believe that:
 - A. Our service to the global church includes the encouragement of the financial independency of the local church.
 - B. The ministry From His Fullness offers is most needed or desired where there is a readiness to make a contribution toward it.

If, having read of these priorities, you feel able to invite From His Fullness Ministries, we request that the appropriate representative of your church or ministry fill out the following application form and sign it (preferably with a hand signature).
